Entry Procedure

- Emailed entries must contain the artist's first and last name in the subject line.
- •The image file name(s) should include artist's first name, middle initial, last name and the title of the artwork as listed on the entry form.
- *Digital images are to be submitted by email or on a CD as high resolution JPEG files with a maximum size of 1.5MB and 300dpi.
- *The image you submit will be used for the online presentation.
- *If mailing a CD, it must be labeled with the artist's name, contact information, and email address.
- ◆Entries postmarked or emailed after February 2, 2022 will not be accepted.

Sales

All works submitted **must be for sale at the price indicated on the entry form**. No changes in price, medium or dimensions nor substitution of art can be made after entry. **TCH will not make any changes to the information provided after entries are received.** The Community House Foundation, a nonprofit organization, retains a 35% sales commission.

Liability and Insurance

The Community House and The Community House Foundation will not be responsible for loss or damage from any cause while works are in our possession or in transit.

Eligibility

This all-media show and sale is open to all Michigan artists 18 years and older. Artists may submit a maximum of 3 works of art, with the exception of jewelry, where 5 pieces may be submitted. Submissions may NOT have been shown in any previous OUR TOWN show. Submissions may not be removed for the duration of the show.

Art Delivery

Artists will be notified upon the sale of their art. The art must then be delivered to The Community House in a timely manner following notification of the sale.
